1. Preliminaries

- (a) Churchill College May Ball (hereafter 'the Ball') is organised and run by the Churchill College May Ball Committee (hereafter 'the Organisers').
- (b) The Organisers may be contacted at Churchill College, University of Cambridge, Storey's Way, Cambridge CB3 0DS.
- (c) Participation at the Ball is subject to, and attendance at the Ball constitutes acceptance of, the following Terms and Conditions.

2. Admission

- (a) To be allowed entry into the Ball, Guests must have purchased a ticket and have a valid form of photographic identification, such as a passport or driving licence. The photographic identification must display a name that matches the name on the Organisers' database and demonstrates that the Guest is over the age of 18.
- (b) The Organisers reserve the right to inspect clothing, containers, packages and bags intended to be brought into the College in order to verify that the Terms and Conditions laid out in this document have been adhered to.
- (c) The Committee reserves the right to refuse entry to inappropriately dressed Guests.
- (d) Entry to the Ball is final. Once an attendee has left the Ball, re-entry is prohibited, except by the prior permission of the Organisers. Wristbands will be provided upon entry to the Ball. Guests must wear their wristbands for the entire duration of the Ball. Lost or damaged wristbands will not be replaced, other than in exceptional circumstances, at the discretion of the Organisers.

3. Health and Safety

(a) Guests agree to comply with Health and Safety legislation and regulations and with any instructions or rules given by the Organisers.

4. Conditions of Admission

- (a) The Organisers and the College reserve the right, with reasonable cause, to refuse entry to or remove any attendees from the Ball. If the Guest is removed from the Ball, they are not entitled to a refund of the ticket price. Reasonable causes include, but are not limited to:
 - (i) If the Guest is deemed by the Organisers to be adversely affected by alcohol or under the influence of illegal drugs.
 - (ii) If the Guest fails to show a valid wristband or photographic ID.
 - (iii) If the Guest is found to have brought a banned item into the College. Banned items include, but are not limited to: food and drink, including alcohol; illegal substances; gas canisters; animals, except service animals; any items which could be considered a weapon; lasers; fireworks, flares or lanterns; drones; glass; flags, banners or signs; musical instruments; amplification equipment; unauthorised

- advertising material or flyers; or any other item deemed inappropriate or dangerous by the Organisers.
- (iv) If the Guest attempts to disrupt any part of the programme; engage in conduct which is a risk to the safety of themselves or others; or engage in any conduct in a manner which bullies or harasses another person.
- (v) If the Guest attempts to cause wilful damage to any part of the College.
- (vi) If the Guest attempts to photograph, film or record the Ball for a reason other than personal use. If necessary to prevent a breach of contract, the Organisers may require Guests to refrain from photography, filming and recording during the Ball. The Organisers will make such a requirement clear on the night of the Ball.
- (vii) If the Guest attempts to interfere with, obstruct or hinder the Organisers, workers, contractors or any member of the College staff in the execution of their powers during the Ball.

5. Photography and Filming

- (a) Guests consent to being photographed, filmed and recorded during the Ball. Such photographs, films and recordings may be released into the public domain for journalistic, marketing or other purposes. All rights to such photographs, films and recordings are retained by the Organisers.
- (b) In order to ensure the safety and security of attendees, the Organisers may operate surveillance equipment within the College.
- (c) Guests consent to their personal information being recorded and disclosed to law enforcement agencies and other persons involved in relevant legal or disciplinary actions, to the extent that the College deems such disclosure to be necessary to protect their lawful interests, the public interest or the safety of persons or property present at the Ball.

6. Liability

(a) To the maximum extent permitted under the law, the Organisers and the College will not be liable for any injury, loss or damage to personal property suffered by Guests during the Ball.

7. Programme

(a) The Organisers reserve the right to alter the programme, menus and other aspects of the Ball without prior notice.

8. Cancellation

(a) In the event that the Ball, or any part of the programme, is cancelled due to a Force Majeure event, the tickets are non-refundable, subject to the discretion of the Presidents. However, all reasonable steps to refund as much as possible of the cost of the ticket will be made. Force Majeure events include, but are not limited to: Acts of God (such as, but not limited to, fire, flood,

earthquake, storm, hurricane or other natural disaster); war; civil war; rebellion; revolution; insurrection; military or usurped power or confiscation; terrorist activities; nationalisation; government sanction; blockage; embargo; labour dispute; strike; lockout, interruption or failure of electricity or telephone service; contamination by a substance with chemical or biological hazard.

(b) Measures associated with COVID-19 are not considered a Force Majeure event

9. General Data Protection Regulation

(a) The Organisers will handle all information provided by the Guest in accordance with the General Data Protection Regulation (GDPR). The information will only be used for the purposes of the Ball.

10. Amendments to Terms and Conditions

(a) The Organisers reserve the right to amend the above Terms and Conditions. Any such alteration will be published on the Ball Website prior to the Ball.
